losses in hive numbers have been recorded for many years previously. As with any biological system, the cause for the decline in the number of bees is complex and most likely the result of a combination of connected issues. The presence of pests, parasites and pathogens are known to stress the health of bee colonies. Regular access to food at specific life stages is essential for healthy hives. Bee management practices, genetic diversity of the bee population and exposure to pesticides have also been proposed to impact colony health.

The Alliance supports development of a pollinator health plan for Vermont, administered by the Vermont Agency of Agriculture, to address the full spectrum of approaches to support pollinator vigor. By working closely with researchers, regulators and producers a pollinator health plan will develop an effective approach to manage the complex interactions among multiple stressors.

In New York, the Alliance has been participating in Governor Cuomo's Pollinator Taskforce commissioned to evaluate and recommend best management practices for the State's pollinator management plan. The Governor's Executive Budget, released last week, contains \$500,000 to implement the management plan which is expected to be released in the near future.

# <u>Guidelines For FSMA Feed Mill Hazard Analysis</u> <u>To Be Developed</u>





The American Feed Industry Association (AFIA) is working with the University of Minnesota's Center for Animal Health and Food Safety (CAHFS) to produce a generic hazard analysis for feed mills, pet food plants and possibly certain ingredient facilities. The AFIA's foundation, the Institute for Feed Education & Research, has contracted CAHFS to conduct the work.

AFIA had an excellent meeting with the Minnesota scientists and 15 AFIA members, discussing the basic questions about what a hazard analysis should look like as the FSMA's final animal food rule is quite specific about what a hazard analysis should contain. AFIA ended the meeting with a number of questions for which it will seek the U.S. Food and Drug Administration's counsel.

The general requirement for a hazard analysis as drafted by the FDA states: "Each facility...must conduct a hazard analysis to identify and evaluate, ... known or reasonably foreseeable hazards for each type of animal food manufactured, processed, packed or held at your facility to determine whether there are any hazards requiring a preventive control..."

The subsection goes on to say that more specific information is also required regarding the type of feed, type of equipment and intended use, and other specific information. For a commercial feed mill making hundreds of different diets, this report will become quite complicated. AFIA and CAHFS are meeting with FDA to determine the type and format of report the agency's officials expect. This will assist in guiding CAHFS' efforts to provide the report FDA expects, while not requiring a facility to do more than needed, be cost prohibitive or drive a facility to create preventive control(s) where none are needed.

AFIA believes the CAHFS report will be an excellent resource for feed mills, but in the end, each facility and its PCQI will need to produce a unique hazard analysis.

### **GMO Labeling Bills Active Northeast Legislatures**

With the January start of the legislative season many northeastern states are debating the adoption of laws to require the labeling of foods containing GMOs. In Vermont legislation passed in 2014 continues to work its way through the state rulemaking process and federal judicial system.



Legislation passed in Connecticut and Maine require "triggers"-combinations of other states with high populations-to pass similar laws before theirs will become active. There is some activity in Maine to request removal of the trigger provision of the law that was passed in 2014.

In New York two bills addressing GMOs will return to original committees for further discussion. Two new bills have been introduced relating to the ban or labeling of genetically engineered salmon.

Two nearly identical bills have been introduced in the Rhode Island legislature that if passed would require GMO labeling. One version of the proposed law would simply go into effect on Jan. 1, 2017. The other version includes a trigger clause. The Rhode Island proposal exempts foods sold directly to consumers from a farm stand from labeling requirements.

During the 2015 session <u>154 out of 200</u> Massachusetts legislators, signed on as cosponsors to the Massachusetts GMO labeling bill in 2015. The bill is currently in the Joint Committee on Environment, Natural Resources and Agriculture.

In New Hampshire there is an effort underway to introduce legislation even though a labeling bill was defeated in 2015. A hearing has been scheduled for late January on a new bill requiring the labeling of genetically engineered food.

The Alliance supports development of a federal labeling law to ensure continuity of commerce across state lines. We are closely following a activity throughout the northeast on development of state level GMO labeling efforts.

# \$15 Minimum Wage to be Key Issue for February Legislative Meetings



The Alliance will be gathering for its Annual Meeting and Forum February 2-3 in Albany, NY and will be meeting with NYS legislative leaders the morning of February 2nd on a number of budget issues, including the proposed \$15 minimum wage. "Alliance members are encouraged to be part of this lobbying effort to explain the significant impact \$15 will have on our industry" explains executive director Rick Zimmerman. "Governor Cuomo introduced the minimum wage increase as part of his Executive Budget. Despite the many positive elements of the Governor's budget, such as small

business tax cuts and funding for key agricultural programs, the \$15 minimum wage will more than offset these economic benefits."

The Alliance is part of a broad based coalition to fight the \$15 minimum wage known as Minimum Wage Reality Check. ## <u>Vermont's Housing and Conservation Board Announces Grants</u> <u>for Dairy Farm Water Quality Projects</u>



The Vermont Farm & Forest Viability Program, an initiative of the Housing and Conservation Board is pleased to announce that funds for dairy farm water quality improvements are available on a competitive basis for grants of up to \$20,000 to Vermont dairy farmers that are members of St. Albans Cooperative or Dairy Farmers of America.

With limited funds available, grant awards will be very competitive and are intended to help farmers make investments in their businesses that result in improved water quality for Vermont's surface waters. In order to apply, farmers are required to fill out an application and demonstrate clearly how their project will result in improved water quality and/or ability to meet regulations.

Funds for this grant program are donated by Commonwealth Dairy, makers of Green Mountain Creamery products and awarded by the Vermont Farm & Forest Viability Program, in partnership with the St. Albans Cooperative, Dairy Farmers of America, Housing Vermont, the Massachusetts Housing Investment Corporation and CEI, Inc.

# Education Critical for Successful Implementation of New Drug Use Policies



A lack of knowledge about new policy requirements on the use of antimicrobial drugs in food animals, as well as access to veterinary services, are critical barriers to the successful implementation of these federal policies, according to a report released today by Farm Foundation, NFP.

"Despite months of work by organizations, agencies and media outlets, many stakeholders lack a full understanding of the policies that have been put in place by the Food and Drug Administration (FDA)," said Foundation President Neil Conklin. "This lack of knowledge is a critical barrier to successful implementation of the policies, which take full effect at the end of 2016."

The Farm Foundation report-- <u>Stewardship of Antimicrobial Drug Use in Food-Producing Animals-</u>- cites the need for state and federal officials to work with colleges of veterinary medicine and professional veterinary organizations to quickly develop options for small producers in underserved areas to have access to veterinary services. A long term need is to

find options to increase the number of veterinarians with economically-sustainable food-animal practices.

The new policies from the FDA require livestock producers to maintain a Veterinary-Client-Patient-Relationship (VCPR) with a veterinarian. But in some locales, including some urban fringe areas, there is a shortage of veterinarians or of veterinarians who treat food-producing animals.

Between August and October 2015, Farm Foundation hosted 12 workshops across the country for veterinarians, feed suppliers and livestock producers to learn about the new policies. Stakeholders were also invited to participate in an online survey, whether or not they attended the workshops. Officials from FDA and USDA's Animal and Plant Health Inspection Service (APHIS), participated in all the workshops-providing details on the policies and gaining feedback on the challenges of implementation.
