Alliance Leads Fundraising Campaign For Cornell University Dairy Scientist

The Northeast Agribusiness and Feed Alliance Board of Directors, in a strong unanimous action, agreed to lead a campaign to assure the continuation of high quality dairy nutrition research and outreach at Cornell University. Under the recently established Faculty Renewal Program, Cornell is willing to match a \$500,000 industry investment and commit to the long term funding of a faculty position when Dr. Larry Chase retires later this year. "This Faculty Renewal Initiative creates a reasonable investment opportunity for our industry" stated Alliance President Bill Colten. "We need to assure that our industry will continue to be served by highly qualified researchers who are on the cutting edge of dairy cattle nutrition and I am very pleased that our organization is stepping up to the plate to lead this effort."



The new faculty position will address dairy nutrition and environmental modeling. Its focus will be research and application of knowledge relating to the use of nutrients by dairy cattle and may include integration of the efficiency of nutrient use with nutritional modeling, nutritional influences on milk components, integration of forage/crop and feeding systems at the farm level, and integration of nutrition and health in dairy cattle. The extension component will continue Cornell's long tradition of active engagement with farmers and agribusiness professionals in New York and throughout the Northeast. The Alliance and CALS will work together to finalize the position description and focus, and to ensure that the highest quality candidates are interviewed for this position.

The campaign to \$500,000 is well under way. Through the generous support of an anonymous

donor, three member companies and the Northeast Agribusiness and Feed Alliance, \$200,000 has already been pledged. Many thanks to Alliance President Bill Colten of Mercer Milling for leading off the campaign with a \$40,000 pledge and to Les Berghorn, of AfgriTech, LLC and Corwin Holtz of Holtz-Nelson Dairy Consultants for their \$10,000 pledges. The Alliance Board pledged \$8,000 a year for the next five years for a total commitment of \$40,000. Former Alliance President John Mitchell and former Alliance Board member and Cornell faculty member Dr. Charlie Sniffen have agreed to lead our campaign to \$500,000. Please give serious consideration to making a pledge. All gift sizes are welcomed!

Alliance Leads Effort to Oppose State Mandated GMO Labeling

Legislators in Vermont and New York are considering bills requiring the labeling of foods containing ingredients from genetically modified crops.



As reported in *Scientific American* in August 2013, "Instead of providing people with useful information, mandatory GMO labels would only intensify the misconception that foods produced with genetic engineering technology endanger people's health. The American Association for the Advancement of Science, the World Health Organization and the exceptionally vigilant European Union agree that GMO's are just as safe as other foods."

The Alliance has led the effort to block GMO labeling recognizing that the proposed labels fail to identify a genuine hazard and could drive up

prices as companies pass the cost of compliance on to consumers.

Furthermore, if food companies choose to not sell products in Vermont and New York, rather than complying with labeling laws, there may be a reduction in consumer choice. Organically produced foods which do not contain GMO's, often sell at a premium. 
Alliance Submits Comments On The Food Safety Modernization Act

On March 31 the Alliance submitted comments to the FDA regarding the regulation of animal feed production and

processing under the Food Safety Modernization Act (FSMA). Additionally the Alliance signed on to comments

delivered to the FDA by the National Grain and Feed Association and the American Feed Industry Association .

Of particular concern to all three organizations was the magnitude of changes encompassed within the proposed rule and the expectation that businesses can evaluate and implement changes to be in regulatory compliance within the time lines outlined. The Alliance stressed that lack of technical assistance to support the ability of businesses to comply would severely stress many of our member companies.



As currently written, the FDA proposes implementing significant testing protocols for the use of by-product feeds (termed "co-products" by the FDA). In some sectors of the livestock feed industry it is estimated that up to 80% of animal food ingredients or raw materials are derived from some form of by-product. The FDA has not been able to identify by-products as a source of a human or animal food illness outbreak. As currently written, the FSMA would require companies producing by-products to conduct testing and draft nutritional requirements and feed practices associated with the management of the by-products they sell to the livestock feed industry. An additional expectation from FDA for human food processors to understand the use of by-products in animal feed may be sufficient to end the practices of using these nutritious and wholesome ingredients in the food chain.

When originally drafted, the Food Safety Modernization Act proposed to exempt facilities such as grain elevators that are "solely engaged in the storage" of raw agricultural commodities, other than fruits and vegetables, intended for further distribution and processing. However, as the exemption language is currently drafted, virtually no grain elevators would qualify because the exemption would be removed if such facilities also performed other common activities associated with the safe and effective storage of raw agricultural commodities, such as screening, cleaning, conditioning and fumigating. The Northeast Agribusiness and Feed Alliance strongly urged FDA to revise its proposed definition for storage so that it also encompasses these and other storage-related activities.

Alliance - PRO-DAIRY Nutrition Conferences Provide Timely Information



Corwin Holtz facilitated a panel of Betsy Bullard of Brigeen Farm in Turner, ME and Mike Chase, Herdsman at High Lawn Farm in Lee, MA describing their experiences of managing robotic milking equipment.

Over 250 people attended the Herd Health and Nutrition Conferences held in conjunction with PRO-DAIRY in Syracuse, New York and West Lebanon, New Hampshire. The audience included feed industry staff, veterinarians and dairy producers from throughout the northeast.

Dr. Stephanie McKay, of the University of Vermont spoke on the Genetics of Feed Efficiency and Applications for the Dairy Industry. Dr. McKay's work focuses on identifying what proportion of genetic variation associated with complex traits such as feed efficiency, is influenced by environmental factors and how environmental factors impact gene expression.

Examples of Innovations in Feed Storage Technology were presented by Dr. Rich Muck of the USDA - ARS Dairy Forage Research Center. Dr. Muck discussed the value of silage packing devices, the use of various plastic films for side walls and covers, and the variation between using tires verses tarps secured with gravel filled bags to secure plastic silo covers.

Corwin Holtz of Holtz-Nelson Dairy Consultants and NEAFA Board member facilitated dairy producer panels at each location discussing On-Farm Technologies for Dairy Production.

Dr. Gordie Jones of Central Sands Dairy in Wisconsin shared his perspectives on achieving excellence on today's dairy farms. His experience in managing 20,000 cows at Fair Oaks Dairy Farms in Indiana and as owner of the 4,100 head Central Sands Dairy in central Wisconsin provided the backdrop for lively and informative discussion.


