

In response to strong opposition from the business community, including the Northeast Ag and Feed Alliance, Governor Cuomo and Thruway Authority Executive Director Thomas Madison announced that there will be **no** toll increase for commercial vehicles using the NYS

Thruway. The Authority undertook an extensive review of their operations and created a three year fiscal plan that avoids any toll increases. Sufficient operations savings have been found including transferring the \$60 million annual State Police Thruway patrol expense to the State of New York.

Success on this issue can be attributed to an effective campaign that included Northeast Ag and Feed Alliance. Many thanks go to all who presented testimony at the hearings or sent statements into the official record.

Alliance Influences FDA Feed Regulation Process

The Ag and Feed Alliance has collaborated with Congress, FDA and industry stakeholders, under the leadership of the Animal Feed Industry Association (AFIA), to advocate on behalf



of the feed industry and counter the effects of the Food and Drug Administration Act (FDAAA) of 2007. As drafted, the FDAAA used the term "ingredient standards" and directed the FDA to develop rules for pet food ingredient standards. FDA was to extend that to all animal foods, as it regulates feed and pet food. The problem has been that "standards" were not defined in the law, and AAFCO (The American Association of Feed Control Officials) uses the term "definitions," as do state feed laws based on the AAFCO Model Feed Bill.

The Alliance coordinated with AFIA, AAFCO, 17 state feed and grain associations and the eight major animal agriculture trade associations expressing their support for fixing this issue either administratively or via a legislative fix. This attention led to FDA agreeing to extend its MOU with AAFCO until 2015. This agreement comes as FDA is committed to

ensuring that the industry will have the ingredient review/approval processes it needs while the permanent fix is agreed upon and able to be enacted. More information will be coming in the next few weeks as we work out the details of the permanent fix.

Election Impacts on Northeast Agriculture

New England and New York are fortunate to have so many returning federal delegates currently serving as champions on the House and Senate Agriculture Committees.

Congresswoman Chellie Pingree (D-ME), Congressman Bill Owens (D-NY), Congressman Chris Gibson (R-NY), Congressman Peter Welch (D-VT), Congressman Jim McGovern (D-MA) and Congressman Joe Courtney (D-CT) all serve on the House Agriculture Committee and all were re-elected this November. Chris Collins a newly elected New York Republican Congressman was just named to the House Agriculture Committee. Long standing Senator Patrick Leahy (D-VT) and Senator Kristen Gillibrand (D-NY) serve on the Senate Agriculture Committee. Many of the gains for the northeast in the pending farm bill can be attributed to our considerable strength on these committees.

In addition to the Agriculture Committees, the <u>Agricultural Appropriations Subcommittees</u> also make crucial funding decisions for programs that serve northeast agriculture. We are fortunate to have Congresswoman Rosa DeLauro (D-CT) who also won re-election serving as ranking member of the Subcommittee. Senator Susan Collins (R-ME) serves on the Senate Agricultural Appropriations Subcommittee.

Five seats will be opening up on the House Agriculture Committee for Democrats as a result of one retirement and four election defeats. The Republicans will have three seats as a result of one retirement and two election defeats. The Senate Agriculture Committee will have three new seats as a result of two retiring Democrats and one defeated Republican. Because the Democrats picked up some seats in both the House and the Senate, additional Democratic seats may be offered on these committees in January.

In Maine the senate seat vacated by the retirement of Olympia Snowe, a reasoned voice on agricultural issues, has been won by former governor Angus King, an Independent who will most likely caucus with the Democrats.

The Vermont gubernatorial election was easily won by incumbent Democrat Peter Shumlin of Vermont. While Shumlin has been challenged on GMO labeling initiatives his support of the Working Lands Investment Act demonstrates a firm commitment to agriculture. In New Hampshire the win by Maggie Hassan kept the Governor's office in Democratic control.

Farm Bill Outlook For Dairy

As this issue of the Alliance newsletter goes to press it appears unlikely that Farm Bill legislation will be considered before the federal recess.

U.S. Senators Charles Schumer, D-N Y and Patrick Leahy, D-VT recently called on House Speaker John Boehner, R-OH, to allow the bipartisan farm bill the Senate passed in August to be brought to the House floor for a vote. "This would affect every New York family," Sen. Schumer told reporters in a telephone press conference. He predicted milk prices to double to \$6 a gallon and higher prices for all dairy products. On the floor of the Senate Leahy remarked "The farmers already confront enough uncertainty running their businesses. When we let farm programs expire without enacting a new farm bill, it needlessly compounds that uncertainty and it is irresponsible."

In related news, New York Senator Kristen Gillibrand joined with others including, northeast senators Olympia Snowe (R-ME), Susan Collins (R-ME) and Bernie Sanders (I-VT) in a letter to Senators Debbie Stebenow (D-MI) and Pat Roberts (R-KS) thanking them for their efforts on dairy pricing reform contained in the Senate version of the Farm Bill. Gillibrand and her peers also emphasized the need to maintain the dairy pricing reform measures in the Farm Bill that is currently stalled in the House.

Because farm legislation expired on September 30, 2012 federal dairy policy is poised to revert to the 1949 system of payments, causing many within the industry to forecast a doubling of the price of milk on store shelves. Despite the dire predictions for escalated prices many within the industry feel that the underlying 60 year old legislation could be repealed, temporarily extending the current price support program buying time for continued discussions in the House.

Alliance Sponsors 10th Annual
Northeast Regional Dairy Challenge

The Alliance was a silver level sponsor of the 10th annual Northeast Regional Dairy

Challenge hosted this year by the University of Maine. The contest drew 105 students from nine northeast colleges and two Canadian universities to Waterville, Maine, on November 1-3, 2012.

The Northeast Regional Dairy Challenge is an innovative, three-day educational competition designed to prepare students for dairy careers. Working in mixed-university teams of four or five students, participants assessed all aspects of a working dairy farm, including facilities, nutrition, financials, reproduction, animal health and much more. Students collaborated on a 20-minute team presentation that detailed their observations and suggestions to a panel of judges and participating farm families. Teams were ranked as platinum, gold or silver based on how well their evaluations matched the judges' evaluations of the dairy operation.


Maine farms evaluated during the 2012 competition included Stonyvale Farm, Exeter; The Wright Place, Clinton; and Piper Hill Farm, Embden. All students also attended an industry career fair, and they participated in educational workshops at Flood Brothers dairy farm near Clinton. Team-building and fun activities were held through the weekend to encourage networking among students and agribusiness sponsors.

For the first time, a Technology Seminar for area dairy producers was held in conjunction with the Northeast Regional Dairy Challenge. Dr. Mike Van Amburgh, Associate Professor in the Department of Animal Science at Cornell University, spoke on Early Life Nutrition and Management Impacts Long-Term Productivity of Calves. Tom Kilcer, owner of Advanced Ag Systems, presented Forage Management and Alternative Forages to Enhance Quality and Reduce Purchased Feed Costs.


